**A List of the Principal Inhabitants of Milford
A.D. 1680-90, taken from the Tithe Account of
the Rev. John Birket, Vicar.**

**To which have been added various details of
their holdings traced in some cases down to
A.D. 1800.**

In Mr. Birket's lists of tithe payers, those who compounded by paying various sums from 1/6 to £2 2s. Od. are placed first in each year. After them are lists, not always complete, of what are probably small holders and cottagers. They paid on garden produce, honey, fruit, and the like—various sums from 2d. to 6d. I have compared the entries in the Registers for ten years, 1680-90, and as far as I can see not more than five or six names have been needed to add to Mr. Birket's Diary. It is of course difficult with such details as are to hand to thoroughly complete an Index, for it is as impossible to say that all cottagers are included as to say that there were no residents in the parish who did not pay tithes. I gather however that some living in Lymington owned land, and especially salterns in Milford or Pennington. Mr. Birket mentions six inhabitants of Lymington who paid £8 4s. 6d. tithes, but whether their names are included in the Index I cannot say—I think not.

In 1686 at the end of each list is an apparent total of the Tithepayers—121, which would give a population of 540. I think this may be taken as the minimum and perhaps 600 as a maximum.

Airey, Mrs. In 1680 paid for an acre of glebe 6/8, and for Rickman's Moors 5/-. The glebe land is apparently the Shorefield Acre, and Rickman's Moors may have been some of the lands now generally called Shorefields or Sharvells outside of and between Barnes' Farm and the Common.

Blake, Ed., in 1682 paid 2d. Tithe. He is described as an Anabaptist.

Brook, Andrew. 1684. Tithe 6d.

Cleeves, William. 1682 7d. 1684 6d.

Reg. 1689. A son bur.

Cotton, William. 1682 1/-. 1684 uxor. 1/-.

Compton, Wid. 1682, 3.

- Dean, Hen. 1680. Tithe 2/6, later 2/-, and then only 6d., after which the name disappears.
- Elms. Elms, Thos., uxor. Tithes 1/-, in 1683-6.
Reg. 1683. Thos. son of Thos. Elms bur.
- Durlin. 1680, Widd. Durlin paid 8/- Tithe. In Mr. Airey's time Goodman Durlin paid the same and the widow continued till about 1690. The land which was part of Westover was held by Mrs. Sydenham in 1692. Much of it has been washed away by the sea, but the holding can be traced in the Rate Books till 1803, when Rev. . . . Close held it.
- Furner. 1680, John Furner paid 2. 6. In 1684 he took John Pitts' (q.v.), 1685, Wid. Furner paid for his funeral sermon and mortuary £1. In 1717 a William Furner is mentioned as paying 6/- Tithes
- Frank. Reg. 1682. Ann Frank of Milford, bur.
- Furzby. In 1680 Will. Furzby paid 10/8 tithe and later several years 10/-. In Rate List 1720 Mr. Birket was rated at £12 p.a. for Furzby's land, which apparently lay interspersed with that of other holders between Sturt Pond and Saltern Lane with a house possibly near the site of the present Cottage Hospital, This family name is interesting for certain connections. In "1684. For Funeral Sermons due" is included "Roland Furzby's wife," possibly father and mother of William. Among the Church plate is a curious silver box and cover inscribed "For to make peace and unity—often used—my mind hoping in heaven. GOD's mercy for to find." Roland Furzby's gift to Milford Church 1638.
- Gates. Bur. Reg. 1680. Maurice Gates of Milford. Maurice Gates had a Saltern in Milford,

Tithe £1, later called "The Mount."

Gee. The Widow Gee (John Gee in 1680) payed 4/- tithe for her land which in 1715 was in the hands of Edward Hicks and was rated at £10. In 1720 it was 12 acres. It continued in the hands of the Hicks family till after 1800, in that year it was rated at £39. In the T. A. Gee's close No. 449 is given as 4·1·17 acres, and 301 1·2·14.

Getheridge. George Getheridge, 1680-5. Tithe 10d.

Gillingham. Wid. Gillingham, 1682-5. Tithes 6d. An *Anabaptist*. In 1688 James Gillingham is mentioned as owing for "apples" but no amount given. The land in Westover called Gillingham probably is so called after Mr. Henry Gillingham and later Mrs. Gillingham who held lands there called Coats and Lillington 1768-77.

Harris. Francis Harris, Tithe 6d. 1682-1685.

Langar. David Langar. *Anabaptist*, Paid tithe for ye Mill $3/4$, 1681. In several years he paid also "for Arnums" $1/2$, in 1689 it is as "for small Tythes" $1/4$. In 1715 Rate Book Jno. Langar was rated at £1 10s. Od., for Comberham Mill and David Langar £3 for part of Barnes. In 1717-19 David Langar paid Tithes for 2 Mills 7/- 1721 Matt. Bayley for 2 Mills 7/- Note in 1721 things titheable, Mills, Efford $6/8$, Wind Mill $3/4$, all the rest $3/4$. "Arnums" or "pt. of

Milford.

- Barnes" is probably in Shorefields.

- Masters. John Masters 1686 in place of John Furner. Reg. 1687, John and William sons of John Masters baptized.
- Moore. Will. Moore, 1685. Tithe 6d.

- Pierce, Abraham. Tithe 6d. 1683-6. An *Ana-baptist*.
Reg. 1682. A son bur.
- Pitt. John Pitt 1680. Tithes 7/6. In 1683 John Furner for Pitts. 1684, for John Furner's Mortuary and Funeral Sermon £1. 1686, John Masters in place of John Furner's Widow. 1692, Ed. Hicks for Pitts—(blank)—included with Hordle. 1715 Rate Book, Ed. Hicks for Pitts rated at £14 p.a. Pitts' land about 36 acres in 17 parcels was fairly distributed all over the tithing from Sturt Water to the Vernesse grounds near Stonyford. His house is now included in Carrington garden or just beyond it.
Reg. 1682. John Pitt of Milford bur., and Sarah wife of John Pitt of Ch . . . ton [=Carrington ?].
- Pope. In 1683 Nicholas Pope succeeded the Widow Tyrril in the second portion of Westover, for which he paid £1 12s. Tithe. He exchanged "during plasure" his ground in Vernesse for the Vicar's acre of Glebe in Shorefields. The date may be quoted as 1718 but is probably earlier 1713-15. In 1717 Wm. Etheridge held the land. 1738 Mr. Wm. Hicks. In 1715 it was rated at £14 5s. and was about 33 acres.

Tyrrel. In Mr. Aireys' "Copy of ye Rates." Rob.
Tirryl held Rickman Moores and Vincorts
for which he paid 7s. tithe. In 1680 Widow

Tyrrill paid £1 18s., in 1681 £1 12s., in the same year Henry Vincourt paid 2/-, and Mrs. Airey pd. 5/- for Rickman Moors. In 1683 Rich. Pope succeeded Wid. Tyrrel at Westover.

Veek. John Veek, 1684-6. Tithe 6d.

Reg. 1680. A son baptized.

Vincourt. Mr. Airey's "Copy of ye Rates" states that Robt. Tyrrel held Vincorts which later was held by Hen. Vincort at 2/- Tithe from 1680-1692 With his own Hy. Vincort held 1680-85 an acre of Glebe for which he paid 10/- rent. In the Rate Book of 1715 Tho. Elmes paid on Rateable Value of £7 for Hen. & Hump. Vincort. In 1720 Wid. Elms held 17½ acres, half called Hy. Vincorts & half Humphery Vincorts. It is interspersed among the fields of the Village.

Wade. From 1680-1692 Thomas Wade paid 5s. 0d. Tithe and 12s. 6d. rent for the five saltern stiches belonging the Vicarage. In 1692 are added the words "and 2 lying places."

In the Terrier of 1696 the entry is "Five Saltern stiches and 2 pieces of lying ground adjoining Thomas Wade's. [The Saltern and Sandhouse belonging to the Vicarage having been pulled down many years.]"

Thomas Wade's Saltern is quoted in 1680 as being in Keyhaven. He paid 30 ambers (=150 gallons) in kind the cash value being 15/- In 1692 the same amount was worth £1 2s. 6d. In 1718 Mr. Wm. White had the stiches & 1731 Mr. Wm. Hicks who paid 17/- for Wades 30 ambers and 15/- for the 5 stiches. The works continued till

about 1782 and were closed at the same time as Mount saltern. They are now covered with shingle: Thomas Wade lived at Carington.

Brice. James Brice paid in 1680 Tithe 3/-. A note adds Ed. Cooper pd. but 6d. for this. Ed. Cooper was of Efford.

Budden. 1683. Wid. Budden, a *Papist* pays tithe 4/-, in 1688 John Curl for Budden's 4/-.

Curl. Reg. 1638. John Corle of Akerton, bur.

Reg. 1669. John S. William Currel of Acreton, bapt.

In Mr. Birkett's diaries the Curls held land in both Keyhaven and Efford 1680, Wid. Curl of Keyhaven, Tithe 8/6. Will. Curl of Akerton in Efford, 3/-. 1683, Keyhaven, Wid. Curl 8/-. Efford, Will. Curl 3/6. Tho. Hicks for Curles, 3/-. Wid. Curl of Acreton for husband's

mortuary due (to pay) 10/-. 1688, John Curl, Keyhaven, His mother's mortuary and for Funeral Sermon due, Tithe 8/-, for Budden's 4/-. 1692-4, John Curl (probably also in occupation of Videvan) Tithe £1 15s. 0d. 1717 (apparently Videvan only) Wid. Curl, Tithe £2 10s. 1718, Akerton not paid for—the Rate books show it was split up into several holdings.

In the earlier years of Mr. Birkett's Diary this name is written Vaux. John Vaux paid 4/- Tithe. As Vaux or Fox his name occurs each year till 1692. It does not occur in Mr. Aireys' Copy. In the Book of Forest Claims of 1670, a name of a tenant of Seth, Bishop of Salisbury, occurs William Frost, the only one in the list not otherwise mentioned in the district. Whether Frost can in any way be a corruption of Vaux is I suppose doubtful. In the Rate Book, 1715, Thomas Woodford for late Foxes was rated at £3 15s. 0d. 1785, Mrs. Brixey for late Foxes. 1800, Mr. Dennett for Brixey's £10 10s. (Rateable Value).
